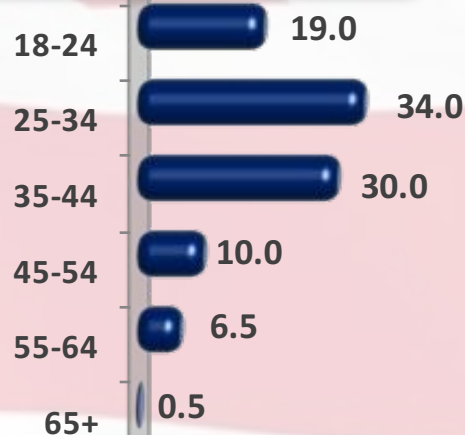

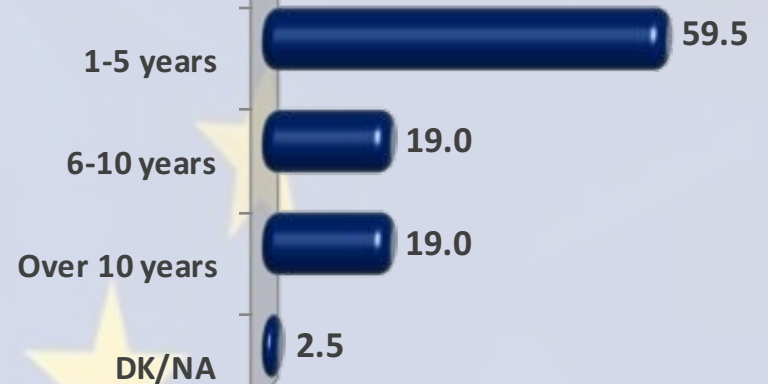

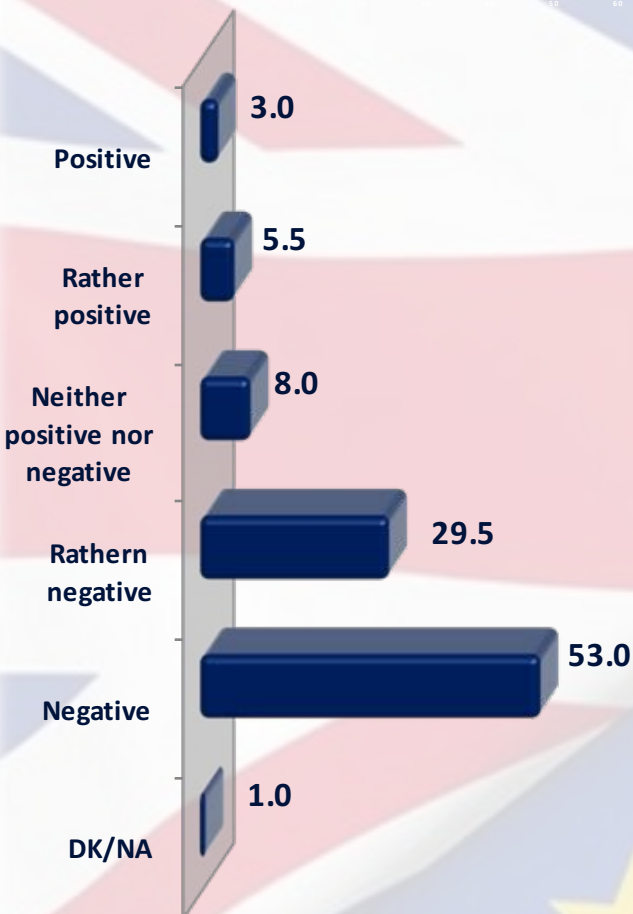

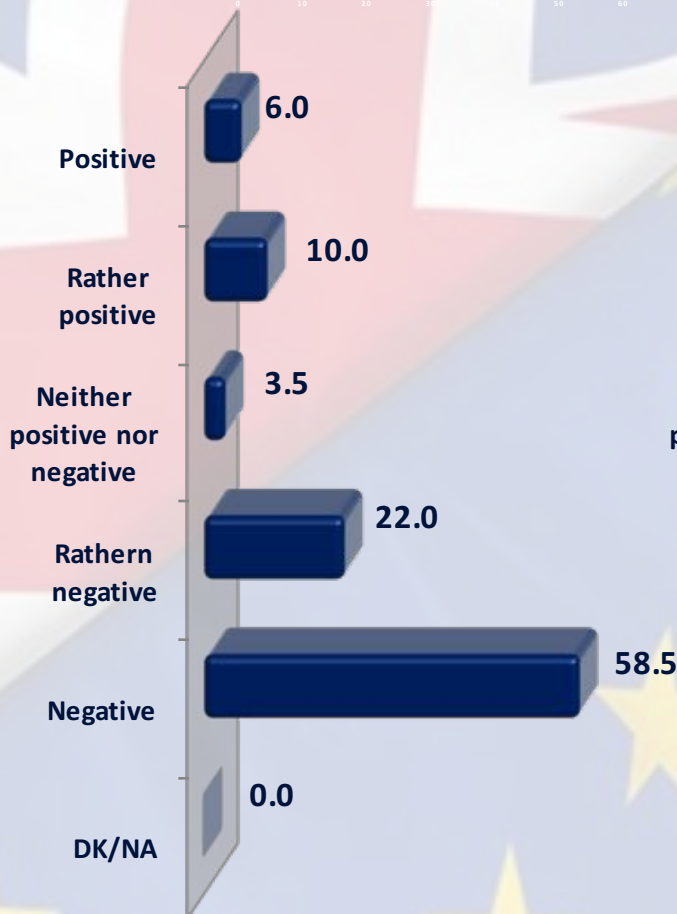
The majority of UK citizens voted in favor of leaving the country by the European Union.

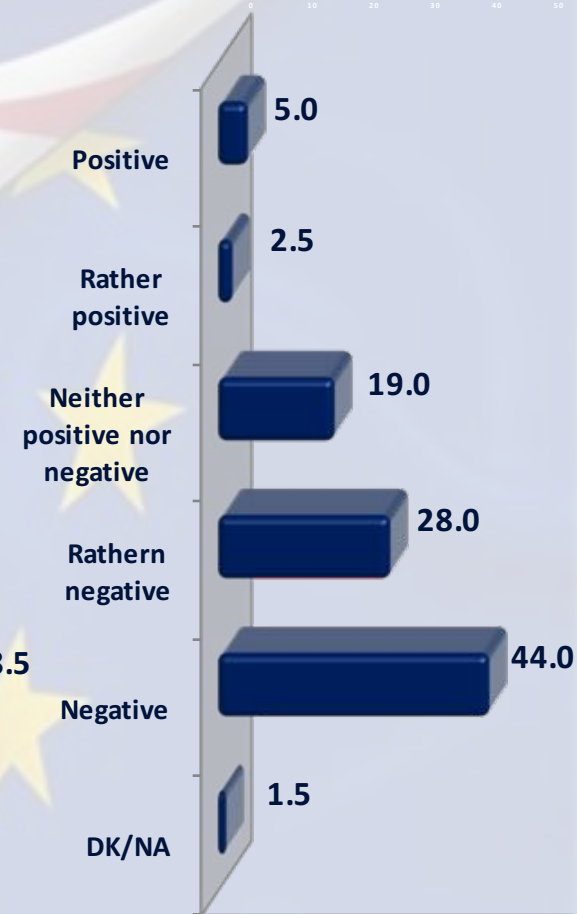

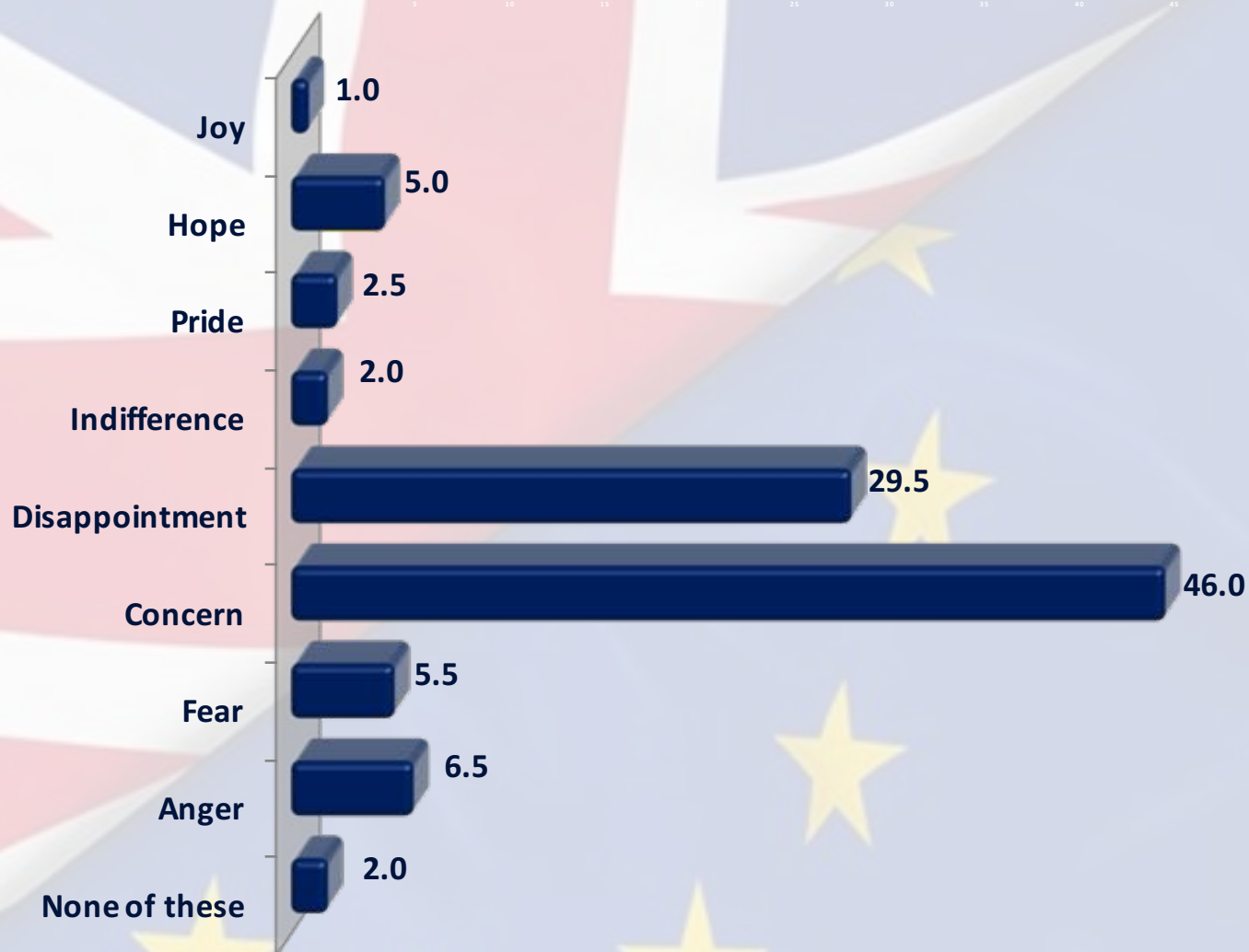

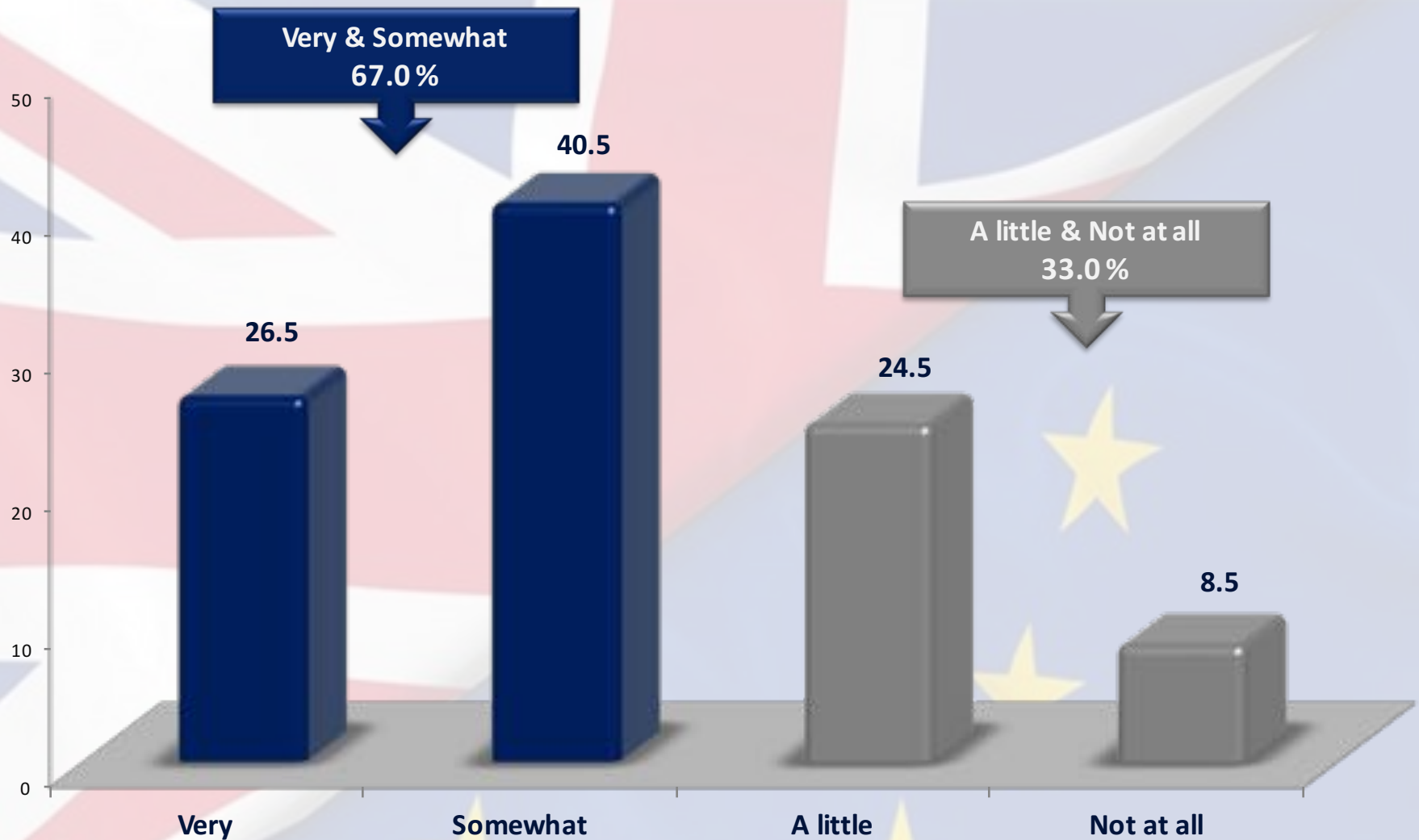
What feeling does the British people's decision to leave the EU bring you?

Specifically, how worried would you say you are regarding the consequences of Brexit?

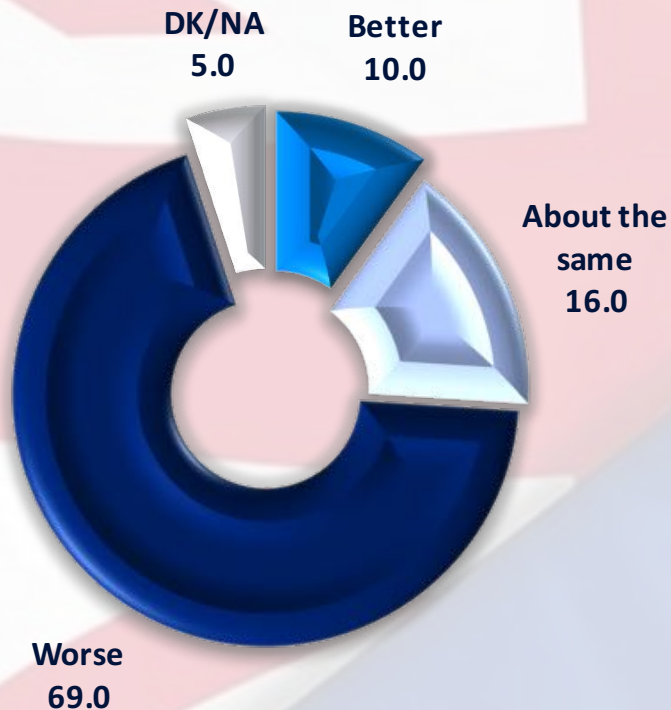

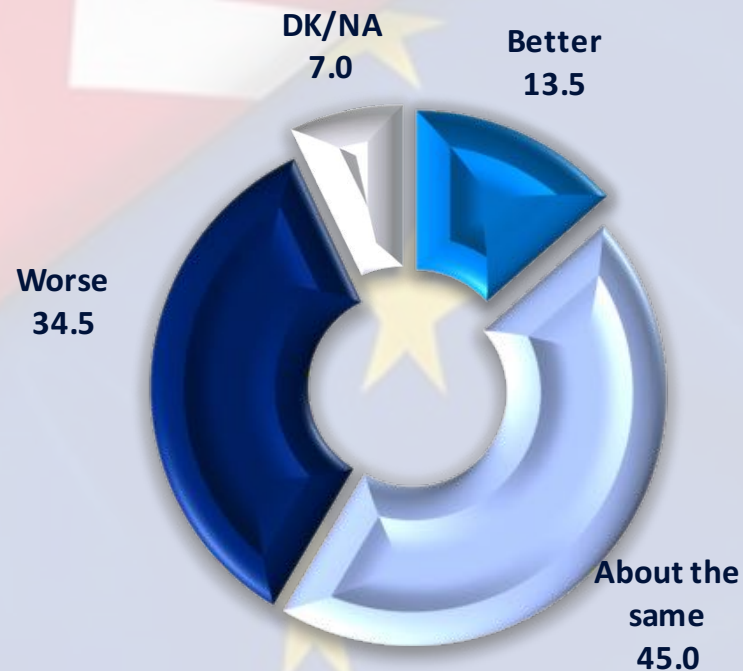

the British economy



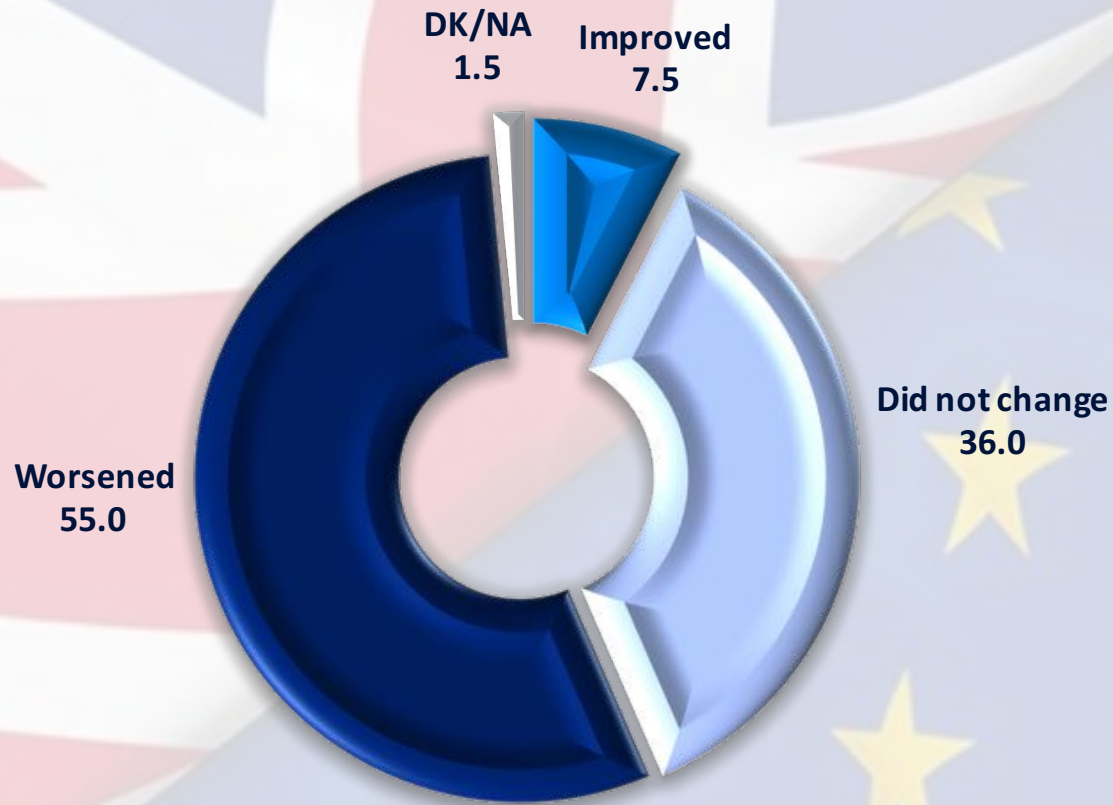

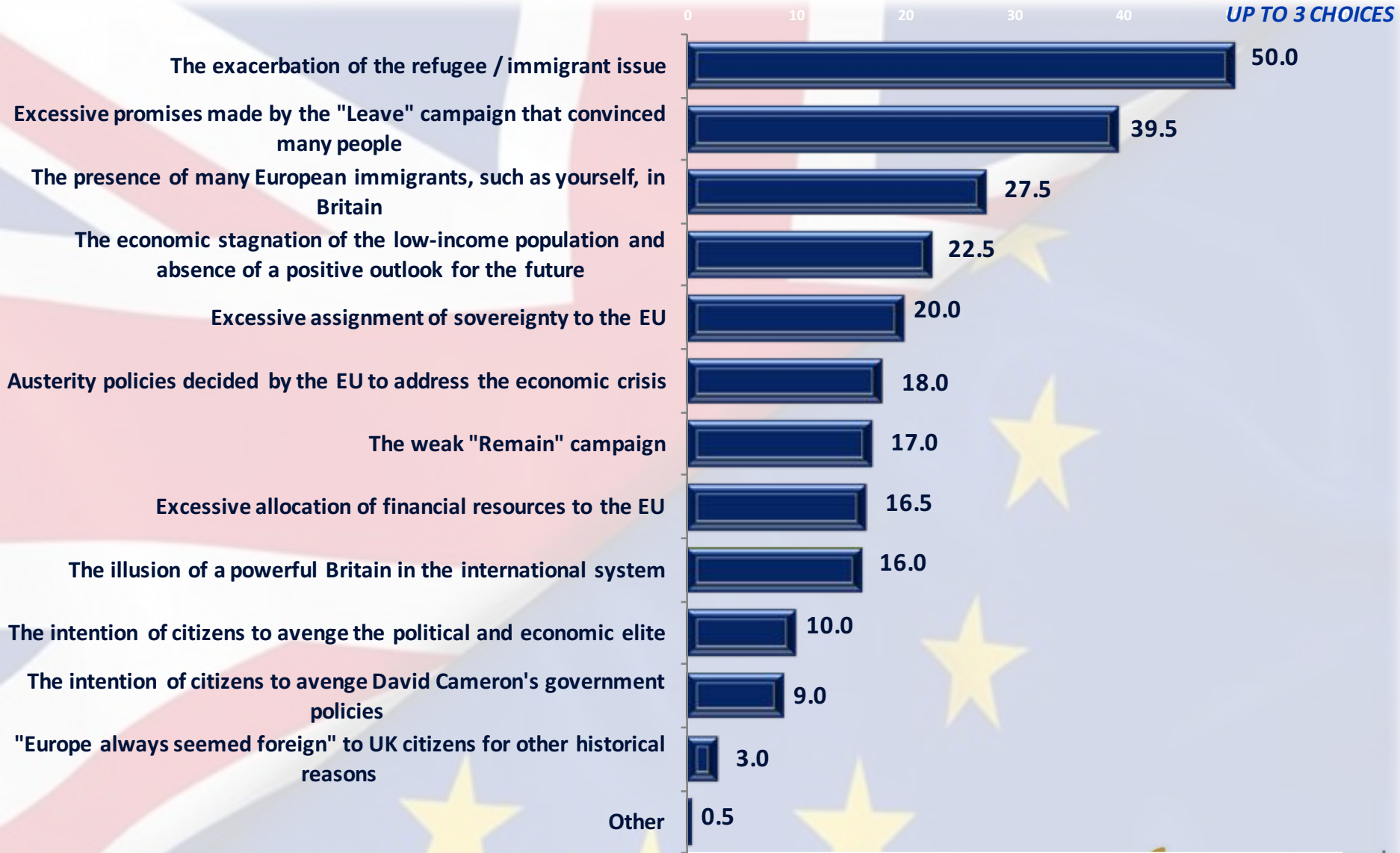
After the referendum on Brexit, your opinion of the British people and of British society...:

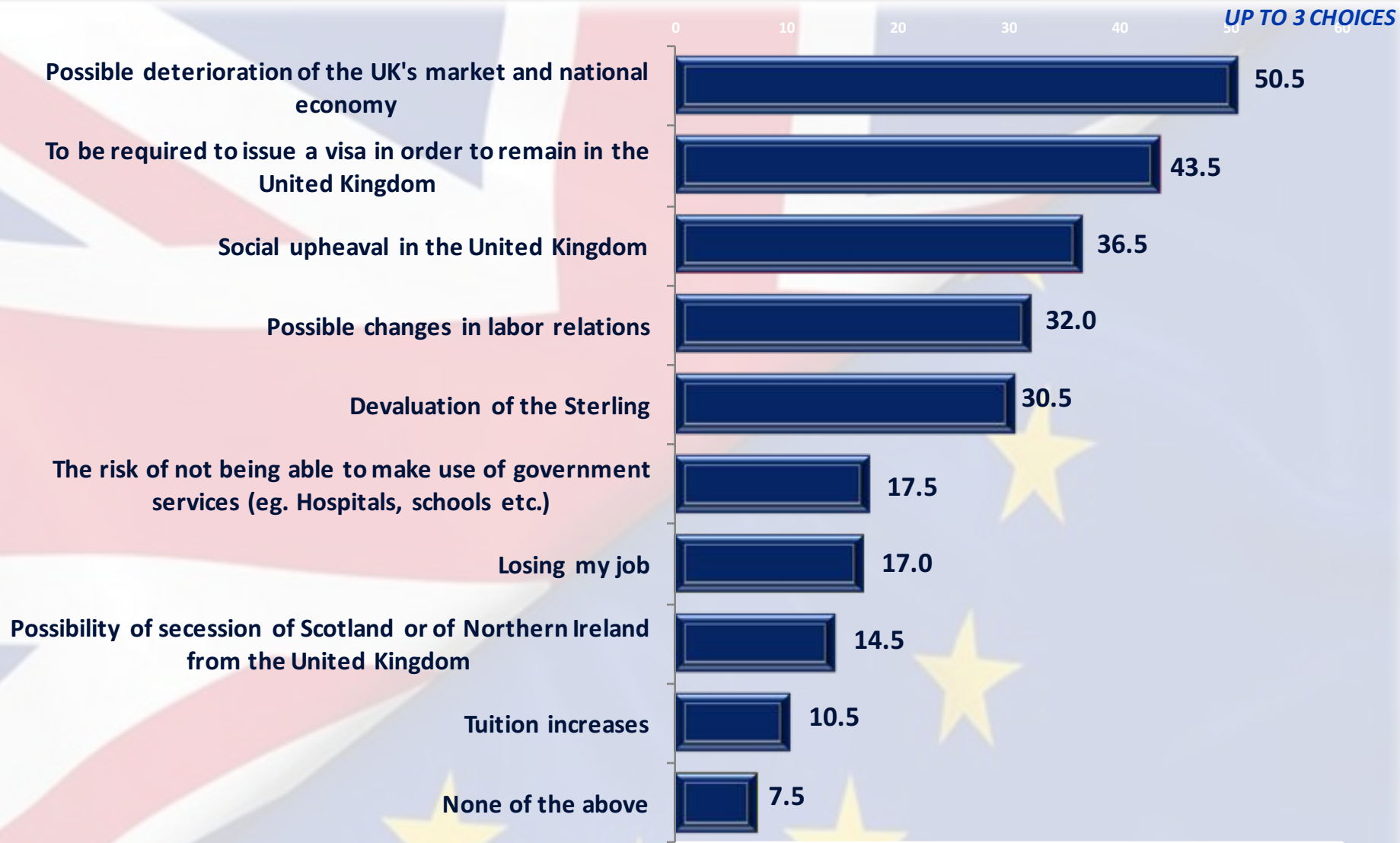
In your view, what was the most important reason the British people voted to leave the EU?

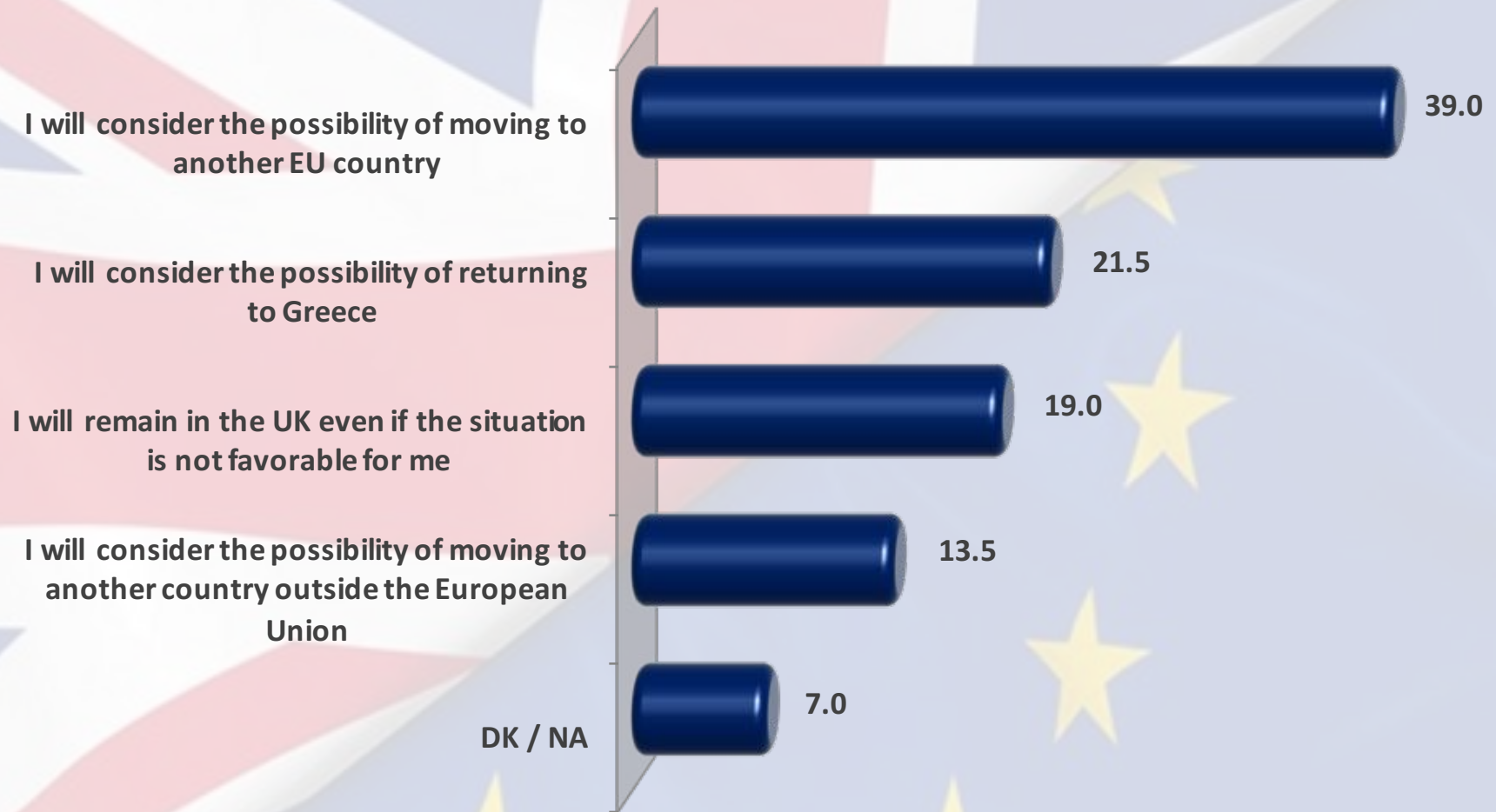
What is your biggest concern after the Brexit vote?

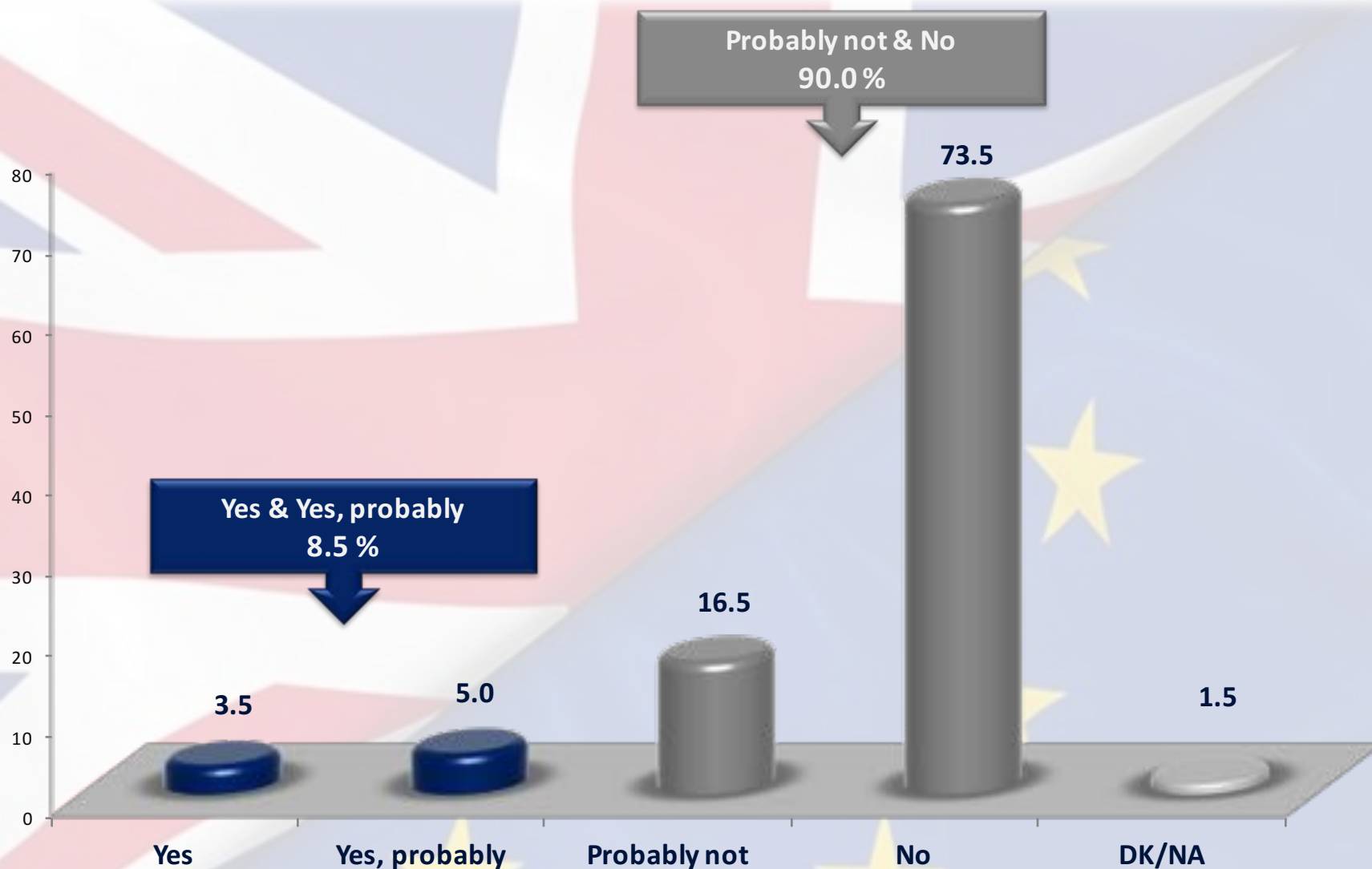

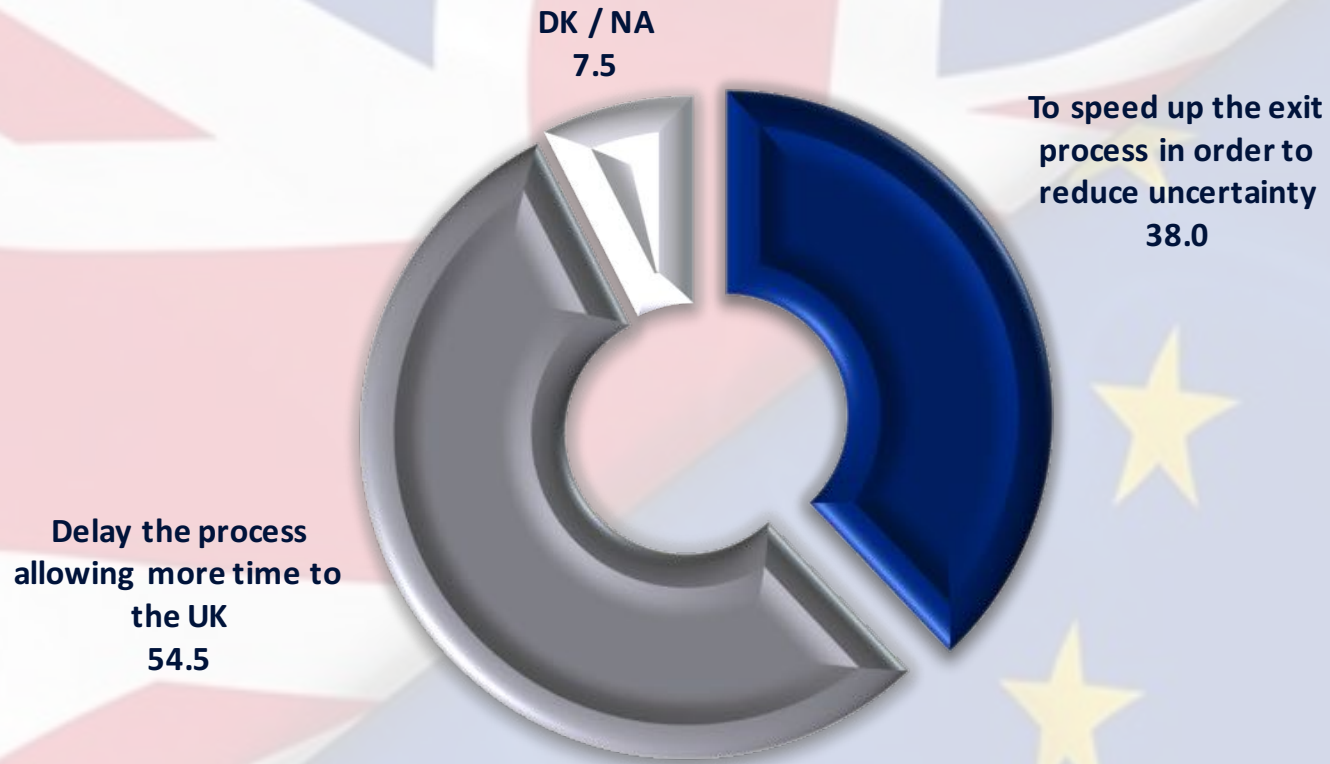

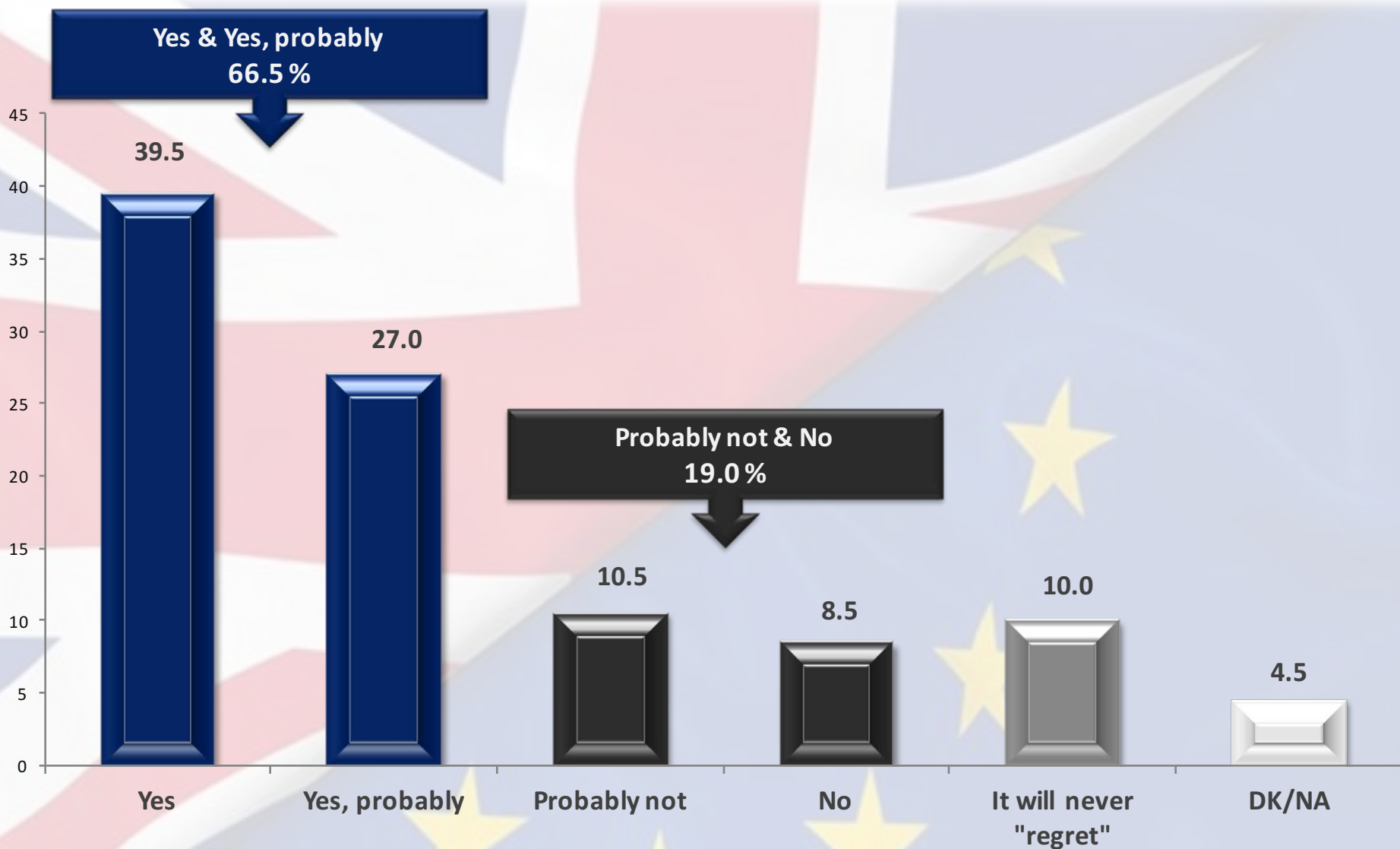
